By purchasing a new, Select Model vehicle from an Authorized Dealer during the Program Period, an eligible purchaser will receive the option to activate a **3-year extended warranty** from Cornerstone United, as further defined below, covering eligible components on the purchased vehicle at no additional cost. The new, Select Model vehicle must be warranty-registered to an eligible purchaser within the Program Period to qualify for the Offer.

Eligibility

This offer is only valid for retail purchases of new Select Model vehicles made in the continental United States by individuals who are the age of majority in their state/province/territory of residence at the time of purchase at a participating Authorized E-Z-GO Dealer; businesses purchasing for commercial use are eligible unless expressly excluded below. Exclusions: Fleet, rental, government, or wholesale purchases; brokered transactions; auction purchases; used, demo, loaner, prior-registered, or previously titled units; and any vehicle purchased outside the Program Period. The 360 Extended Warranty is a limited warranty provided and administered by Cornerstone United, and is subject to the terms, conditions, exclusions, limitations, and claim procedures in the 360 Extended Warranty contract issued to, and executed by, the customer at or after purchase of a Select Model vehicle. Coverage activation may require customer registration or dealer submission. Failure to complete activation steps may result in forfeiture. Warranty service will be provided at authorized providers as specified in the written warranty. Use of any particular brand of parts or service outside of warranty repairs is not required to maintain coverage. Full written warranty terms are available for review prior to sale at participating Authorized Dealers, and are hereby incorporated into these Program Terms. In the event of any contradiction between the 360 Extended Warranty and the Program Terms, the 360 Extended Warranty will control.

Activation

At the time of purchase, the participating Authorized Dealer will confirm whether the vehicle and sale is eligible for the Offer and submit warranty activation to the Administrator or provide activation link/code for customer to complete activation within the same time. Customer must provide accurate information for activation and retain proof of purchase and activation confirmation.

Additional Details

Program is offered by Textron E-Z-GO LLC (“E-Z-GO”). “Program Period” is from the Start Date to the End Date, inclusive of those dates. “Authorized Dealer(s)” are only those dealers which have a current agreement with E-Z-GO for the use of E-Z-GO trademarks and governing the purchase and sale of E-Z-GO products to the general public, as prescribed by relevant local laws. Program cannot be combined with any other offer unless expressly permitted in writing by E-Z-GO. Program may be discontinued at any time without notice.
